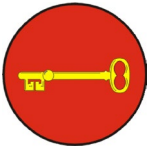

This closes my third year as your Knight's Marshal. When I accepted the office, I made known my plan to focus on the following goals:

Goal: Regular, dependable armored practices.

Results: Successful & ongoing. We had very few weeks this year without practice being held. Most were due to holidays.

Goal: Rehabilitation of the shire's stock of loaner armor.

Results: Progress made & ongoing. We are currently taking an inventory of loaner gear for the Exchequer.

Goal: Revival of a melee team program in the shire.

We also had displays of handmade crafts contributed by our members. This event proved to be very popular and we had close to 400 visitors over the course of four hours.
- Rendezvous at the Bridge XXXIII, October 14, 2023; This was reasonably well attended given the unexpected cold weather and chilly rain. Rendezvous was attended by 148 people and was quite a success. It was attended by Their Majesties, King Wigthegn and Queen Neassa. They gave out the following awards to shire members:
